### **Election of Executive Board Members**

- Garrett reviewed duties and expectations of two Executive Board member positions up for election. Kristine Bartz had left the neighborhood and her remaining term needs to be filled.
- Nominating Committee did not have any nominees.
- Nominations were taken from the floor.
  - Sean Flagg was nominated for 3-year term
  - o Don Leach was nominated to replace the 2-year term vacated
  - No other nominations
- Open vote was taken to floor in place of paper ballots

### **ACC Update**

- Fran and Garrett welcomed the new homeowners to neighborhood and gave a brief ACC update and status of the neighborhood.
- Fran discussed ACC responsibilities and walk-around process to new homeowners. Homeowners agreed to continue the walk-around process.
- Garrett asked for two new volunteers to serve on ACC for a two-year term. Kim Cooper and Dan Sewzcak volunteered. Fran to remain current chair. The five ACC members include: Fran Planinsek, Mickey Martinez, Doug Sharp, Kim Cooper and Dan Sewzcak. Fran to gather information from new ACC members and coordinate next meeting and neighborhood walkaround.
- Dan and Heather Sewzcak presented plans to ACC for their new house addition and perimeter fencing.
- Discussion about abandoned Owl Lake sign landscaping. ACC to revisit and submit proposal.

### **Irrigation System Update**

- Garrett and Sean discussed the catastrophic failure of the VFD controller and pump motor issues due the electrical problems that occurred in the fall.
- The HOA's previous irrigation system contractor was no longer in business. The HOA reached
  out to others in the area with similar irrigation systems for suggestions. After many positive
  referrals and discussions, the HOA decided to use Ramey Environmental, a local irrigation/pump
  specialist to maintain and manage our irrigation system.
- Ramey Environmental installed a new VFD controller and rebuilt the pump and bearings just in time for the 2017 watering season. With proper maintenance, this should last several years.
- Backflow Testing Backflow testing was completed, billing will be on their 3<sup>rd</sup> quarter invoices.
- Section 18 / MSP Development No news, development has stalled at the moment.
- The HOA has partially secured leased water and will continue to search for opportunities.
- Garrett and Sean reminded the homeowners about water conservation, recommended watering guidelines and that there are no guarantees in terms of water availability.

### **Neighborhood Happenings**

- Carbon Valley Rec District Letter Discussion A brief discussion was held about Owl Lake addresses now included in the tax district. Not much we can do, no action taken.
- Mickey Martinez and Fran Planinsek to plan a friendly neighborhood breakfast/gathering and send notices out.
