

- Garrett reviewed duties and expectations of an Executive board member position up for election.
- Nominating Committee did not have any nominees.

- Open vote was taken to floor. All in favor

ACC Update

- Resume quarterly walk around and reporting. Most issues are with vehicles violations and weeds.
- Garrett asked for another volunteer for ACC. Mickey Martinez was recommended again, Mickey Martinez was re-appointed to ACC Committee. This makes the voting easier with 5 individuals on committee.
- We had 3 Architectural Requests in 2016. All were approved.
 - LeFevre Completed
 - Sharp In progress
 - o Hall Abandoned. This property has been sold again. No new info as of yet.
- Don Leach asked if we had documentation on camper issues in the past assuring we were in compliance, in case we had to have proof in court. ACC keeps those on file.

Water Update

- Pump is on and the blowouts are done. Back Flow testing had a few issues which are resolved. The prices went up \$5.00 this year, bringing the charge per resident to \$40.00.
- Going to try and keep the water pumps running 24/7.
- We have had first water fill, outlook for water looks good. As always, no guarantees.
- We still own White Rock Water shares, which is stored in Panama. Very hard to get any answers.
 Sean is trying to get hold of new Ditch Rider so we can lease or sell. Will continue to look for storage water.
- Pump Issues: There was no power to the Meter. United Power had a fault in their meter, they
 disconnected and reconnected our power to the pump. The issue has been corrected but we
 will keep an eye on it for possible failure again. If it occurs again, United Power will temporarily
 provide a generator.
- Need to talk to our neighbors, even though the pumps will be on all the time, please do not
 water during hot hours or for long periods. We still need to conserve water.
- MSP development has stalled on building. Developer is finishing to North East corner only. Land will most likely sit vacant.

Neighborhood Happenings

 Garrett added a weather station to the Owl Lake Estates Website. It gives current updated weather info for our area.
